A limited number of good quality tack and equipment (i.e. sleighs, buggies, stock trailers, saddles, and harness) will be accepted, **BUT MUST BE PRE-BOOKED** with Brennin at (306) 533-2495.

ENTRY FEE: \$65.00 Per Head – horses will not be considered entered until the nomination form is signed and returned with payment. The sale committee has the right to accept or decline any horse or horses. Entry fees will be returned to consignors whose horses have not been selected for the sale.

CLOSING DATE FOR NOMINATIONS: THURSDAY, APRIL 15, 2010 (all consignors will be notified if they are accepted into the sale by Friday, April 23, 2010)

TERMS OF CONSIGNMENT

1. Registered horses of any breed are eligible: Ranch, Pleasure, Broodmares, 2yr olds, and Yearlings. A mare & foal sold together as a pair are one entry. Grade horses are eligible but must be well broke saddle or driving horses.
2. Notice: Only horses consigned to the “Promise of Summer” will be allowed on the sale grounds. **ALL HORSES MUST GO THROUGH THE SALE RING. ABSOLUTELY NO ALLEY TRADING.**
3. For registered horses a copy of the registration paper must accompany the entry form and fee (transferred into the current owners name). Original registration papers, with transfer signed in ink, must be handed into the sales office by 10 a.m. on sale day or the horse will be sold as grade. The transfer and the cost of transfer will become the responsibility of the purchaser.
4. Selling Commission will be 5% of the selling price with a minimum of \$50.00.
5. Reserve prices are discouraged, however, please indicate if there will be a reserve price on your horse(s). Any reserve price must be made in writing and in the hands of sales management by 10:00 a.m. on sale day. This is your final reserve. You cannot decide in the ring if or how much your reserve price will be, nor can you change your reserve price while in the ring (i.e. reserve of \$2500.00 and the final bid is \$2475.00 the horse will be a pass out). If sales management does not receive a reserve price, the horse will sell to the highest bidder. Horses not meeting their reserve price will be charged a \$40 pass out fee and cannot be removed from the auction mart until the fee is paid.
6. There will be a Never Offered or No Show fee of \$100.00, once your entry has been accepted.
7. Horses ridden in the ring will be sold with a soundness guarantee to buyers unless the seller represents the horse as not 100% sound at sale time. Buyers claiming non-soundness must deliver a vet certificate by 3:00 p.m. Monday, June 7, 2010 to Heartland Livestock Services (HLS) Regina. In this case, the buyer must return the horse to HLS Regina and the seller must pick up the horse. The buyer will receive a full refund and the seller will not be paid for the horse. We at HLS consider sound to be sight out of both eyes, hit the ground sound on all four and not to crib.
8. HLS is acting as an agent, only, and represents the horses as represented to us by the consignor, and is not liable for any misrepresentation.
9. Payment to sellers: cheques will be mailed or can be picked up at 4:00 p.m. Monday, June 7, 2010.
10. Public viewing of the horses will be from 9:00 a.m. until 12:00 noon on sale day. At this time you will have the opportunity to demonstrate your horses skills (cattle will be available).
11. The sale catalogue will be made available on-line at www.hls.ca by mid-May and one catalogue will be mailed for each horse entered.
